### 2011 Green U Farmers Market Requirements

The Green U Farmers Market is an opportunity for local farmers and ranchers to sell their products and let community residents know where they can find sources of local food. The market is limited to local farmers and ranchers and organizations representing local farmers, Any organization representing more than one farm will provide information on the individual farmers that they represent. **Note: This is a producers only event.**

Food items allowed for sale may include, but are not limited to: vegetables, fruits, meats, eggs, baked goods, honey, ciders, flowers and plants. Farm products must come from your own farm – no buying and re-selling of products is permitted.

Any producer wishing to advertise their products at the market as Organic or Naturally Grown must provide documentation of certification or a signed affidavit if exempt from certification.

Any value-added farm products such as jams, jellies, pickles, and baked goods must be prepared in a certified kitchen; the exemption for prepared foods at farmers markets does not apply to this event. Vendors selling value-added products are responsible for obtaining a valid business license from the Alabama Department of Revenue.

The market will be held under 20x30' tents (*size subject to change*), with the number of tents determined by the number of participants. Each vendor will be provided with an 8' table. Products will need to be off-loaded from vehicles, please schedule enough time on Saturday morning to do so. Spaces are to be manned at all times; signage and/or backdrops that identify your ranch or farm are required. Vendors should be set up and ready by 9:30 a.m. on Saturday morning. Spaces are to be cleared no later than 5:00 p.m.

A representative's signature is required to show acceptance and understanding of restrictions and obligations. (See signature block at bottom of this page.)

**All applications will be considered on a first come, first serve basis and are subject to final review and approval by the Event/Festival management. Confirmation of your market space and additional details will be sent the first week of August.**
